The current situation in Europe can be described as an "energy paradox". Economic slowdown and the growth of both the energy consumption and the share of bio-fuels in the energy mix revealed a need for urgent reforms of the EU energy system. At present, some assumptions of the so-called road map are in contradiction to the rules of market competition. Will the ongoing debate on the EU climate and energy policies till 2030 bring an expected compromise on environmental protection and some solutions aiming to reinforce the energy security, with account taken of the economic differences between the EU member states? How to accelerate the integration process of the energy infrastructure? Where is room for cooperation between the countries of the Central Europe? And, finally, what is worth investing in so uncertain times? These and other issues will be discussed during this year's Energy Forum in Sopot.
